Knowing these facts, and in consideration of you accepting my entry, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on my behalf, covenant it not to sue, and waive and release and discharge any and all race sponsors, race officials, race volunteers, local and state police including any and all their agents, employees, assigns or anyone acting for them on their behalf from any and all claims or liability for death, personal injury or property damage of any kind or nature whatsoever arising out of, or in the course of, my participation in this event whether same be caused by negligence or fault. This release and waiver extends to all claims of any kind or nature whatsoever, foreseen or unforeseen, known or unknown.
